NOTIFICATION

- G.S.R. In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Bureau of Police Research and Development (Hindi Translator) Recruitment (Amendment) Rules 1985 in so far as they relate to the certain posts, except as respects things done or omitted to have been done before such supersession, the President hereby makes the following rules to amend the method of recruitment to the post of Hindi Translator in the Directorate of Forensic Science Services, Ministry of Home Affairs, namely:-
- 1. **Short title and commencement:** (1) These rules may be called the Directorate of Forensic Science Services Hindi Translator, Grade II (Group B) Recruitment (amendment) Rules, 2018.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Application:** These rules shall apply to the rules specified in the Schedule annexed to these rules.
- 3. **Number of posts, classification and Level in the Pay Matrix:** The number of posts, its classification and the level in pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 4. **Method of recruitment, age limit, qualification etc.:** The method of recruitment to the said post, age limit, qualifications and other matter connected therewith shall be as specified in columns (5) to (13) of the said Schedule.
- 5. **Disqualification:** No person, -
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who having a spouse living has entered into or contracted a marriage with any person; shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing exempt any person from the operation of this rule.

- 6. **Power to relax:** Where the Central Government is of opinion that it is necessary to expedient so to do, it may, by order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category or persons.
- 7. **Saving:** Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the order issued by the Central Government from time to time in this regard.

Note 1: Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.

The maximum age limit for appointment by deputation shall be "Not exceeding 56 Years" as on the closing date of receipt of applications.

Note 2: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale and where this benefit will extend only for the post(s) for which that grade pay of pay scale is normal replacement grade without any upgradation.
