- G.S.R. 2.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Bureau of Police Research and Development, ministerial (Group 'B') posts Recruitment Rules, 1976, in so far as it relate to the post of Stenographer Grade II, except as respects things done or omitted to done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Stenographer Grade I in the Directorate of Forensic Science Services, Ministry of Home Affairs, namely:-
- 1. Short title and commencement. (1) These rules may be called the Ministry of Home Affairs, Directorate of Forensic Science Services, Stenographer Grade I (Group 'B' post) Recruitment Rules, 2021.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification and level in the pay matrix. The number of post, its classification and the level in pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. **Method of recruitment, age-limit, qualifications, etc.** The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the aforesaid Schedule.
- 4. Disqualification. No person, -
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - **(b)** who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:
 - Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
- 5. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category or persons.
- 6. Saving. Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen and other special

categories of persons in accordance with the orders issued by the Central Government from time to time in

The maximum age limit for appointment by deputation shall be 'Not exceeding fifty six years' as on the closing date of receipt of applications.
